UNFINISHED BUSINESS

1. Venable Park Memorial

Robert Morrissey read prepared comments regarding the Venable Park memorial jury process. These comments were previously emailed to Mayor Hoffman and read to the City Council at the November 14, 2022, Council meeting, delivered as an individual and not as a representative of the Arts Committee. Morrissey's comments stated that the Arts Committee should have been involved in the initial development of the Venable Memorial Artwork Project Plan and requested the City Council open the Venable Park Memorial jury to all Arts Committee members instead of limiting the jury to two representatives.

Liz Bockius and Scott Saunders stated they were comfortable with the process that the city followed. Linda Kusmer stated she would support Morrissey's request to allow more than two representatives from the Arts Committee to be on the Venable Park Memorial jury.

Staff liaison Melissa Bradford shared a comment on behalf of Council liaison Sari Neudorf, who was unable to attend, recommending that committee members listen to the interview audio between Dr. Venable and the Missouri History Museum that is posted on the city's website.

2. Free Little Art Gallery

Lisa Hilton presented the proposed materials, rules and color of the Free Little Art Gallery to be installed at Millennium Park. Hilton recommended that the city purchase a kit from the Little Free Library website so that the final product is waterproof and consistent with the existing Little Free Library. This was proposed instead of asking an Eagle Scout to construct the box because there was concern the Eagle Scout would not be able to construct a steel, weather-proof roof. The Committee voted to approve the color yellow for the Free Little Art Gallery.
