2. Sister City Proposal

Matt Rizzo, member of the Parks and Historic Preservation Committee, provided additional information to the Arts Committee about the Sister City Proposal with Cesson-Sévigné. Matt stated the city has no historical ties to antisemitism. The City Council reviewed the proposal during the work session on February 13 and responded favorably to the idea.
