Melissa Bradford confirmed purchasing a sculpture would reduce the city's number of rotating sculpture sites. Lisa Hilton stated that part of that discussion would be weighing the value of creating conversation with new artwork versus the value of establishing an iconic piece at that location by purchasing a permanent one. Sari Neudorf suggested hosting an event to celebrate the installation of the new sculptures.

The Committee discussed the upcoming Arbor Day event on April 30th. Robert Morrissey suggested incorporating a sidewalk chalk activity at the Committee's booth. Melissa Bradford stated she would email a layout of the event and photos from past years to the Committee.
