2. Electric Vehicle Subcommittee Update

Andy Lowenthal provided an update on the Electric Vehicle Subcommittee's progress, which was established to evaluate the financial and environmental pros and cons of electric vehicles. Andy noted that the benefit of EVs is reduced in Missouri because of the reliance on coal. Tire pollution is also greater for EVs. Saranya Konala stated the City has budgeted an EV pickup truck and EV charger for the Government Center. The goal of the next subcommittee meeting is to draft a recommendation on how the city should move forward on EV purchases.

Greg Campbell asked if there has been any conclusion if EVs are better than hybrids? Saranya stated there is not a meaningful difference between EVs and hybrids in
