UNFINISHED BUSINESS

2. Plein Air Art Event

Melissa Bradford reviewed the event to-do list and estimated budget with the Committee. Pier Alsup asked about last year's budgeted amount for food. Melissa Bradford explained that food was offered to the artists and volunteers only, and that the Committee will eventually need to discuss if they would like to budget for food for this year's event. Pier Alsup asked if the event received any media coverage last year. Melissa Bradford stated that West News Magazine published an article about the event afterward.

3. Track Lighting at Tappmeyer Homestead

Robert Morrissey provided an update on this project. Robert met with Public Works staff

to discuss the possibility of installing track lighting at Tappmeyer Homestead, potentially connecting the lighting to the existing recessed lights. Melissa Bradford stated that staff will look into it to see if this idea is feasible.

4. Sculpture on the Move Update

Robert Morrissey stated that the new sculpture in LaVerne Collins Park has been installed. Robert recommended that, in the future, the Committee consider the flatness and quality of a piece. A more fully dimensional sculpture would be better suited for the LaVerne Collins Park location.

5. Free Little Art Gallery

Lisa Hilton stated that the Free Little Art Gallery (FLAG) in Millennium Park is not receiving much engagement and is often empty. She recommended promoting the FLAG and possibly painting the outside of the wooden box to draw attention to it. The sign also needs to be replaced with something larger and easier to read.

6. Arbor Day - Sunday, April 27, 2025

Melissa Bradford stated she purchased a craft activity for the Arts Committee table. Robert Morrissey recommended that sidewalk chalk also be available. Robert Morrissey, Lisa Hilton, and Pier Alsup volunteered to attend Arbor Day.

The Committee discussed including a "guess where this sculpture is" feature in an upcoming newsletter.

Lisa Hilton stated that the sculpture in Malcolm Terrace Park has been removed. Melissa Bradford stated she would check with Public Works about the removal of the remaining sculptures.
