4. Plein Air Art Event 2026

The Committee reviewed the existing flyer and suggested adding a photo of the band performing, adjusting the subheading to include a reference to music, and adding "3rd Annual" to the title at the top. Melissa Bradford stated she will print sponsorship flyers for committee members to distribute, and she will bring information about the suggested juror to the next meeting.

For the event, committee members agreed to raise the price from \$40 to \$45. The additional money would go toward advertising the event through new avenues. Committee members also agreed that the rules should emphasize that artwork must remain on the walls until the end of the event.

5. Sculpture on the Move 2026

Melissa Bradford provided an update on the program, stating that the artist has now signed the contract committing to installation this spring.

6. Venable Park Memorial

Melissa Bradford provided an update on the sculpture installation schedule, stating that the artwork will be installed in late April. The park's grand reopening celebration will be held on May 16.
