The Creve Coeur Police Department has been approached by Edward and Ronald Chod who would like to make a donation to the Police department in the amount of \$35,000.00 to help with the purchase of new workout equipment for the workout room in the new Police building.

The PD was asked to provide a competitive figure that would allow us to equip a workout room for the new facility. The PD sought some competitive pricing for equipment that would fulfill our needs.

The payments would be made out to the City of Creve Coeur and be held until the entire payment is made at which time we would go out for competitive bids.
