4. New Business

A. New Chamber Executive Director

New Executive Director of the Creve Coeur-Olivette Chamber of Commerce (CCOCC) Tom Lancia introduced himself. Mr. Lancia worked 18 years for the archdiocese in the youth ministry office. Priorities for the CCOCC include building value for the existing membership, building membership, and membership retention.

B. Creve Coeur Business Awards Nominations

Committee discussed ideas for promoting the Creve Coeur Business Awards. Ideas included: a paid Facebook ad, a billboard ad for one month through the Chamber's contract; including the 2019 winners in the solicitation for nominations in the February business e-newsletter; and, posting yard signs around the City.

Staff liaison Sharon Stott discussed various City promotions completed to date including: a flyer was included in business license renewal letters in December and mailed to approximately 1,100 businesses; two articles appeared in residential newsletters; two articles appeared in business e-newsletter with two more articles planned; and posting on the City's website.

Tom Lancia stated he had mentioned it at the Chamber luncheon yesterday and would include it in the weekly newsletter this week. Sharon Stott will give him flyers to distribute after the meeting.

Council liaison Charlotte D'Alfonso encouraged EDC members to promote nominations through members various networks. She will promote with the City Council.

Committee discussed having the Chamber host the event again at the Chamber membership meeting luncheon on May 21, 2020.

5. Business from Members

No discussion was held.

6. Business from the Staff Liaison

A. Creve Coeur Building Code & Permit Fees

Jason Jaggi stated the City raised its building permit fees \$1 for every \$1,000 of value. The City's goal is to recover 80% of costs associated with inspections and keep costs are inline with other cities in the region. It has been approximately 7 years since the City has raised its fees.

Mr. Jaggi discussed the City is proposing to adopt the 2015 international building codes. The first reading occurred and the 90-day notice period commenced January 13, 2020. The second reading, and possible approval could occur on or after April 13, 2020.

Mark Perkins stated the city generally adopts building codes in sync with St. Louis County to ensure we are using the same, or similar, codes. St. Louis County recently adopted the 2015 with amendments to the energy code. Mr. Perkins stated the Home Builders Association recommended changes to the St. Louis County energy code due to the added expense of building homes for compliance. The City anticipates receiving similar feedback during the 90-day comment period.

1. Proposed Building Code Changes

B. Medical Marijuana Permits

Jason Jaggi discussed the marijuana cultivation, manufacturing and transportation permits were recently released by Missouri State and no applicant in Creve Coeur was approved. The State will be announcing dispensary permits on January 24, 2020.

Charlotte D'Alfonso stated there is a petition to permit a vote for recreational marijuana.

C. Benson Hill

Mr. Jaggi stated Benson Hill construction is well underway. This ag-tech firm had its start at the Helix Center.

D. 20-Apartment Complex

A proposed 20-unit, 4-story apartment complex is proposed for the "CB" district on the north side of Olive Boulevard, west of Spoede Road. This is an approved use for the CB zoning district and does not require Council approval. Planning and Zoning will review the plans tonight.

E. East Olive Rezoning

Mr. Jaggi stated a draft overlay zoning district was presented to Planning and Zoning (P&Z) Commission last month and a few changes were recommended. Staff will present the revisions to P&Z next month.

F. 39 North Greenways Plan

Mr. Jaggi stated the 39 North Greenway Plan is a portion of the overall Centennial Greenway plan. It has been a 2-year development plan to identify on street and off street trails within the existing environment by 39 North. The plan is on tonight's P&Z agenda. The trail currently ends at Olive Boulevard and I-170, but will eventually reach from Forest Park to Creve Coeur Lake.

G. Opportunity Zones

Mr. Jaggi stated 39 North is part of the census tract included in the Opportunity Zones - primarily near Old Olive and the Light Industrial area.
