4. Unfinished Business

A. Median Design-Olive Blvd.

Mary Deweese shared with the committee through Zoom, three design options to utilize down Olive Blvd. After each design was presented, the committee discussed pro's and con's regarding each design. The committee then picked the design they preferred and asked Jim Heines, Director of Public Works to give his opinion on which design would be the most cost effective and easily maintained by his staff.

The majority of the committee choose the design that matches the N. New Ballas Road median design. Jim Heines, Director of Public Works, raised the concerns regarding the volume of coleus that would need planting every year and the cost. Mary indicated that the plantings can be spaced

further apart to create a fuller bush effect and suggested we could utilize red barberry in alternating pattern. This would offer form during the winter months. Concerns were addressed about plants being salt resistant. Yarrow would be used as the filler and Mary suggested we start with a test patch for one year to see how it would do. Majority of the committee felt that trees would not be needed at this time in the plantings.

B. Honeysuckle Recog Letter

The committee is ready to implement the acknowledgement for honeysuckle removal. Janet will change one word in the introduction from "congratulate" to "acknowledge" and when the letter is ready to sign, notify Jim Graham to stop by the Gov't Center to sign. Fran Cantor will get the address of the homeowners and sent to Janet.

5. New Business

A. Millennium Park Basin

A resident, David McCoy, presented to the Committee his concerns over the mowing of the basin in Millennium Park. David indicated that the mowing destroys so much of the native plants and flowers for the wildlife and environment and wanted to discuss alternatives. David provided before and after photos of the mowing.

Control burns and later mowing times were proposed as a solution.

Jim Heines, Director of Public Works, provided an explanation for the mowing process in the basin. His team of employees had spent many weeks ridding the area of wild Bradford Pear trees which had over grown the area. One way to manage the clearing of invasive plants such as pear trees and honeysuckle is mowing. MSD instructed the city to maintain the swells by cleaning out any debris. The bottom of the basin is designed to hold water for 72 hours prior to draining completely and then drying. In order for Jim's crew to get in there for the cleaning, it must be dry and July and August are the best times for this. Any later and there is not enough manpower to take care of the swells and leaf vac which can start around September.

There are no resources to design and maintain a "prairie" type basin and without proper management, if seed were thrown, the current weeds could and probably would choke out any attempts to establish. Jim Heines mentioned a plan to seed the rims of the basin with wild flowers. Jim Graham mentioned he may want to do that in "test" sections first to see how well it will establish.

Jim Graham thanked David McCoy for bring this to the committee's attention.

6. Comments from the Public

Jim Graham asked David McCoy to go ahead and speak to the Committee about the proposed Parks and Stormwater Use Tax hoping to be added to the November ballot. David McCoy is a member of the Creve Coeur Parks and Historic Preservation Committee and shared with the HEB Committee information about the use tax scheduled to be on the November ballot and asked for support of it.

7. Business from Members

The article for the August city newsletter drafts were discussed and the members were very happy with Melissa Orschlen's version and approved it to go in the newsletter.
