**A. Capital Improvement Plan**

- Park Bridge Replacement
- Middlebrook Culvert Improvements
- Golf Course Pond Siltation Removal

**i. Kofkoff Channel (6 Windrush Creek East)**

Mr. and Mrs. Kofkoff, the residents at 6 Windrush Creek East, have submitted a concept plan for the rehabilitation of the creek channel in their front yard. Staff has concurred with their approach, and the plans have been submitted to MSD for review and approval.

**ii. Mayer Back Yard (12 Wedgewood)**

Staff will share the guidance provided to Mr. Mayer regarding his erosion concerns in his back yard.

**C. Stormwater Projects Update**

**i. Parks Bridge Replacement**

This project involves creek and bridge abutment work to protect an existing vehicular bridge from erosion. The design approval process has led to a modified design and has taken some time to complete. If the project scope and cost can remain reasonable, this project will be proposed to be moved from the current fiscal year (FY2018) to either FY2019 or FY2020.

**ii. Middlebrook Culvert**

Staff is beginning to seek the easements needed to complete this project. Construction is expected to begin in fall 2018.
