VIII. Unfinished Business

A. Residential Stormwater Regulation

The City Council passed the Stormwater Committee's recommended changes to the Stormwater Regulation at their meeting on March 23, 2020.

B. Stormwater Concerns Update

Staff will update the Committee regarding stormwater concerns that residents have recently brought to the Committee's attention.

i. Bellerive Garden Cemetery

Staff met with the owner of the cemetery on February 24 to relay the nearby residents' concerns about stormwater runoff and pond leakage. The cemetery agreed to rebuild sections of the berm and to test the pond for leaks. Work on the berm was completed shortly thereafter, and testing of the pond will be scheduled this summer.

In addition, MSD cleared a storm drain that was apparently clogged and had caused the inlet to back up.

C. Capital Improvement Program

The City relies upon sales tax revenues to fund most of its capital improvement program. The current pandemic has resulted in less physical shopping and dining in Creve Coeur. The result is lower

revenue for improvements. Several of the City's capital improvement projects have been delayed. Staff will review the implications to stormwater-related projects with the Committee.

D. Stormwater Projects Update

Staff will review the status of stormwater-related capital improvement projects with the Committee.

i. Middlebrook Culvert Replacement Project

The project to replace the failing culvert beneath Middlebrook Drive has been advertised for bids. Staff intends to present a construction contract to the City Council on April 27. Construction is expected to be finished by the fall with restoration complete by the end of the year.

ii. Culvert at Ladue and Spoede (MSD)

A failed drainage culvert beneath Ladue Road has undermined the sidewalk and edge of pavement, and both remain closed to traffic. MSD is nearing the completion of their design and easement acquisition. Construction is expected to begin this summer.

iii. Ladue Bridge over Smith Creek (MoDOT)

MoDOT remains on schedule to replace the bridge that carries Ladue Road over Smith Creek (between Laduemont Drive and Chasselle Lane). This project will begin after Memorial Day, and Ladue Road will be open to traffic before school starts in August.
